The CDC Foundation managed hundreds of programs in the United States and in more than 140 countries, and support more than 180 community-based organizations to increase uptake of COVID-19 vaccines in the last year.

# **FUNDING OPPORTUNITY**

The CDC Foundation was awarded a federal grant from the CDC to implement *Leveraging Centers for Independent Living (CILs) to Increase Vaccines for People with Disabilities.* The aim of this project is to increase uptake of COVID-19 vaccinations in individuals with disabilities by engaging with local level CILs that have not received federal funding to assist in implementing COVID-19 vaccine activities including, but not necessarily limited to, transportation, vaccine clinics, and providing feedback on a national hotline. Through this Request for Proposal (RFP), the CDC Foundation seeks to enter into an agreement with a successful bidder to facilitate and support discussions among CILs and state and local health departments (SLHDs). The overall goal of this program is to promote productive discussions between CILs and SLHDs to

overcome barriers to collaboration and increase vaccine accessibility for people with disabilities. Working in close collaboration with public health and disability experts, the contractor will design a facilitator guide to enhance collaboration between SLHDs and CILs.

Bidders are requested to propose the best and most cost-effective solution to meet requirements, while ensuring an elevated level of service and adherence to tight timelines. The budget ceiling for this work shall not exceed \$500,000.00.

## **BACKGROUND**

Approximately sixty-one million adults living in the US have a disability, representing 26% of the adult population. Most people with disabilities are not more likely to become infected with or have severe illness from COVID-19. However, some people with disabilities might be more likely to get infected or have severe illness because of underlying medical conditions, congregate living settings, or systemic health and social inequities, and/or difficulty complying with mitigation strategies. The presence of underlying medical conditions puts others at increased risk for severe illness. Vaccinating people with disabilities poses unique challenges including ensuring physical accessibility of vaccines and vaccination sites. To address these challenges, successful vaccine programs for people with disabilities will best be achieved through collaboration with subject matter experts and recognized leaders in their communities such as disability-led organizations and health departments to ensure vaccines available to the public are truly accessible for everyone. To support and facilitate this collaboration, the CDC Foundation seeks a subcontractor to work with the CDC Foundation, subrecipients and contractors, CDC, and other stakeholders to achieve the following outputs:

- Create a program guide, in partnership with project stakeholders, to facilitate and support discussion among CILs and health departments to overcome barriers and increase vaccine accessibility for people with disabilities.
- Facilitate a series of webinars between CILs and SLHDs to encourage discussion and collaboration and pilot the CDC Foundation's partnership guide during planned CIL and SLHD webinars
- Provide a report of key strategies, challenges, successes, and lessons learned from the facilitated webinars, including the number of CILs and SLHDs engaged.

The subcontractor will facilitate discussions between CILs and SLHDs to ensure CILs are supported in their efforts to increase COVID-19 vaccine uptake among people with disabilities and for health departments and CILs to understand the mutual benefits of partnership and ensuring vaccine accessibility for people with disabilities. The program will consist of a two-tiered approach to the facilitated CIL and SLHD discussions:

- <u>Facilitated joint webinars:</u> These webinars will promote conversations between participating CILs awarded grants in this project and SLHDs that have accepted an invitation to participate in the webinars. There may be CILs and SLHDs from varying parts of the United States joined together to work through case studies or guides developed by the facilitator to discuss and overcome barriers to collaboration.
- <u>Facilitated one-one-one webinars:</u> These webinars will promote conversations between
  participating CILs awarded grants in this project that have expressed interest in having one-oneone discussions with a health department in their authority and a SLHD that has accepted the
  invitation to participate in the online seminar. The CILs and SLHDs participating in these

discussions will be in the same geographic location and they will work through their own case studies or be provided supplemental guides developed by the facilitator to discuss and overcome barriers to collaboration.

# **SCOPE OF WORK**

This program consists of facilitating and supporting discussion among CILs within thirty-nine jurisdictions and SLHDs across the U.S. Working in close collaboration with the CDC Foundation, public health and disability experts, the selected organization will collaborate with other CDC Foundation contractors, subrecipients and staff that are implementing components of the overall project. The contractor must also provide focused consultation to other CDC Foundation contractors and staff that are implementing components of the overall project, as well as work collaboratively in facilitating health department and CIL discussions by developing guides, case studies, and best practices to promote productive discussions and piloting the CDC Foundation partnership guide toolkit in selected communities.

<u>Project Approach</u> – The overall project approach includes the following activities, outputs, performance measures, and budget period outcomes as detailed below.

- 1.1 **Program Activities** The following activities are supported under this Agreement:
  - Partner with CDC Foundation staff and contractors to develop an effective guide to facilitating discussions among CILs and SLHDs
  - Facilitate and support a series of fully accessible online seminar discussions between CILs and SLHDs to improve collaboration and pilot the CDC Foundation partnership guide
  - Submit a report on key strategies, lessons learned, challenges and successes from the online seminar facilitated discussions
- 1.2 **Process Measures** CDC Foundation will use the following indicators to measure the extent to which the activities above have been accomplished:
  - Number of partners engaged in developing the facilitation guide for CIL/SLHD discussions
  - Number of webinars conducted
  - Number of CIL/SLHD engaged in each online seminar
  - Number of times piloting the partnership guide on an online seminar
  - Report provided to the CDC Foundation on key strategies, lessons learned, challenges and successes from the webinars

#### **Submission of Proposals**

Proposals must be submitted to LaTasha Callis at <a href="Leallis@cdcfoundation.org">Leallis@cdcfoundation.org</a>. It shall be the Offerors responsibility to obtain a confirmation of receipt of the CDC Foundation of their submitted proposal. Note that proposals recevied after the deadline may be disqualified from funding consideration. Note that the confirmation of receipt of required submission is confirming the delivery and receipt of the proposal submission and is not a confirmation that the proposal submission is complete or responsive. Application materials should be submitted by 12:00pm EDT on August 12, 2022. Proposals will not be accepted after this date and time. We recommend you begin to submit your proposal by 11:00am EDT to allow sufficient time to address any unexpected technical issues.

## **SELECTION PROCESS AND REVIEW CRITERIA**

**Review of Written Proposals:** Completed eligible applications submitted by the deadline will be evaluated and scored in accordance with the reivew criteria stated below. Written proposals will be evaluated on offerors' qualifications, expertise, and criteria below. The following table outlines the criteria that reviewers will use to guide their evaluation of each written proposal. The CDC Foundation anticipates funding a single proposal based on the multi-stage review process outlined below.

#### **Level 1 Internal Review:**

CDC Foundation will conduct an administrative review of all applications evaluating for completeness and minimum requirements as detailed in this RFP. Basic requirements include timely receipt of application and submission of all required attachments. Applications with omissions of any required documentation may be subject to disqualification.

### **Pre-Award Risk Assessment**

The CDC Foundation reserves the right to conduct financial and due diligence reviews. As a public entity, the CDC Foundation has a responsibility to the public to ensure that the organizations that receive grant funds are financially stable and to evaluate each applicant's risk of noncompliance with Federal statutes, regulations, and the terms and conditions of the subaward for purposes of determining the appropriate method of monitoring.

#### **Level 2 External Review:**

Applicants that pass Level 1 review will proceed to Level 2 review. Proposals that meet the organization eligibility criteria will then undergo a content review by three reviewers. Proposals will be evaluated and scored based on responses in the Proposal Narrative. Proposals will be scored on a scale of 0-100 points. Only proposals that have an average score of 70 points or more will be eligible for consideration for funding. High scoring applicants will proceed to Level 3 Review if applicable.

# **Level 3 Interview (subject to change based on need):**

The highest scoring applicants from the Level 2 Review may be invited for an interview to verify proposal content prior to final award decision. Only key personnel on the proposed RFP must attend the interview. The interview will provide an opportunity for reviewers and finalists to address any follow-up or clarifying questions.

All applicants will receive a notification of whether their proposal was selected for funding. The CDC Foundation will not provide scores but will provide specific review of feedback to unsuccessful applicants upon request.
