Nominations for the James and Sarah Fries Prize for Improving Health and/or the Elizabeth Fries Health Education Award should be submitted online. Self-nominations are not permitted. The Fries Awards Jury may request additional information if necessary, following submission of your nomination.

Letters of intent to nominate are encouraged (but not required) by January 31 at 11:59 PM EST each year. To submit a letter of intent, please prepare to use the appropriate online form below to state who you plan to nominate, for which award, and why you feel this nominee is a good candidate for the award (not to exceed 175 words.)

For all James and Sarah Fries Prize for Improving Health nominations, please be sure to include **quantitative evidence** of the impact of their work in the full summary.

For all Elizabeth Fries Health Education Award nominations, please be sure to include how the nominee's work has **benefited the health of the public** in the full summary.

- 6. DESCRIPTION: (not to exceed 350-word count)
  - A concise description of the specific area (opportunity or challenge) that the accomplishment addresses, including a discussion of the rationale for and development of the accomplishment, degree of originality and/or innovation, and noteworthy collaborators.

For all James and Sarah Fries Prize for Improving Health nominations, please be sure to also include the **health impact on the public** in the description.

For all Elizabeth Fries Health Education Award nominations, please be sure to also include the nominee's **education of the public** in the description.

For both awards, the nomination **MUST describe the role of the nominee specifically in this work** and should discuss any noteworthy collaborators, if applicable.

- 7. DOCUMENTATION:
  - Provide documentation of the nominee's accomplishments, including references and citations demonstrating the importance of the contribution and its suitability for the prize. (Not to exceed 350 words.)
- 8. SUPPORTING MATERIALS: (Please upload these documents to the application)
  - Letter of support ONE (not to exceed 350 words) from an individual who is not an institutional colleague of the nominee.
  - Letter of support TWO (not to exceed 350 words) from an individual who is not an institutional colleague of the nominee.
  - An abridged curriculum vitae (CV) of the nominee; not to exceed 350 words.
  - $\circ~$  A listing of the titles of ten selected seminal articles or other communications, if appropriate. Not to exceed 350 words.
  - An unabridged CV (or more comprehensive document) to serve as a resource, if necessary, for the Fries Awards Jury.

### SPECIAL NOTES:

- $\circ$  Additional supplementary materials will not be considered.
- The Fries Foundation Board and Fries Awards Jury strongly discourage nominators from collaborating with nominees during the nomination process.

## **About the Awards**

The late Dr. James F. Fries, formerly professor emeritus of medicine at Stanford University, came up with the idea for the James and Sarah Fries Prize for Improving Health in a 1987 ascent of Nepal's Makalu—one of the world's highest peaks—when his party became trapped in a severe snowstorm and was ultimately unable to scale the mountain. Following that experience, Dr. Fries returned to sea level and set about establishing a foundation to support a Nobel-like prize for health that now annually awards a \$100,000 prize to an outstanding leader judged by an expert panel to have done the greatest good for the greatest number of people in the field of health. In 1992 the Elizabeth Fries Health Education Award was established in honor of Elizabeth Fries, daughter of James and Sarah Fries. The \$50,000 prize is awarded annually to an individual judged to have made substantial contributions to their area of health education and health promotion. Sarah Fries remained active in the Fries Awards for Health program until her death in May 2017, and Jim Fries remained active in the awards until his death in November 2021.

The CDC Foundation is honored to partner with the James F. and Sarah T. Fries Foundation, which established and funds the award. As of 2016, the CDC Foundation manages and administers the Fries Awards for Health program, which includes the James and Sarah Fries Prize for Improving Health and the Elizabeth Fries Health Education Award.
