### **PURPOSE**

The CDC Foundation is issuing this Request for Information (RFI) to identify a pool of pre-qualified individuals from whom we will solicit and select consultants to fulfill future Infection Prevention Control (IPC) consulting projects in up to fifteen low-and middle-income countries that are receiving grants from the Global Fund. Selected consultants will support efforts to strengthen and expand existing IPC programs with a particular focus on project management, monitoring and evaluation, and supply chain management. Respondents to this RFI that are found to be technically capable will be added to a pool of prequalified potential suppliers. As specific consultant projects are identified, the CDC Foundation will release a Request for Applications (RFA) or other solicitation to the list of pre-qualified potential suppliers and select consultants using evaluation criteria specific to each project.

Individuals that choose to not respond to this RFI/SSN will not be precluded from responding to other funding opportunities released by the CDC Foundation.

# **SOURCES SOUGHT DESCRIPTION**

The CDC Foundation's work includes a wide variety of capacity building activities across the entire organization. This includes the development of recommendation and best practices from the field, collaborations with consultants to provide specific technical assistance, the assessment of programming, sustainability and communication and more. At any point in time, the CDC Foundation is implementing more than two hundred donor-funded projects and programs across the United States (U.S.) and in more than 140 countries. The organization works with partners worldwide to strengthen the global public health workforce; extend emergency response efforts; research and implement effective disease prevention and health promotion strategies as well as implement interventions to address a wide variety of community health, infection prevention and control activities. Technical assistance support is essential to the success for the IPC work.

# **SERVICES AREAS**

Selected consultants will be an integral part of the IPC Technical Assistance (TA) project team working to support implementation of IPC activities in countries supported by The Global Fund (GF) in this discipline. This project focuses on strengthening IPC in fifteen low-and middle-income countries that are receiving grants from the Global Fund. Consultants will support efforts to strengthen and expand existing IPC programs with a particular focus on project management, monitoring and evaluation, and supply chain management. The selected consultants will work in collaboration with Centers for Disease Control and Prevention (CDC) subject matter experts in the countries and at CDC headquarters, Ministries of Health (MOHs), GF country teams, and implementing partners in-country.

# **Major Duties and Responsibilities**

- 1. Provide technical assistance onsite to support IPC activities in healthcare settings and at the national level
- 2. Support IPC activities by engaging with the MOH or other relevant stakeholders
- 3. Support assessments of current IPC programs, policies, and practices and provide guidance on quality improvement

- 4. Collaborate with CDC, MOH, GF country team, and other relevant stakeholders to support the identification of gaps in existing IPC programs and the development and implementation of activities to address those gaps
- 5. Conduct monitoring and evaluation to establish targeted outcomes and measure progress
- 6. Participate in additional activities and other duties as assigned
